#### Call to order

President John Conrad noted the presence of a quorum and called the meeting to order at 7:30 am.

### **Approval of Minutes of February 18, 2015**

#### **Public Comment on Pending Agenda Items**

Mr. Conrad asked if there were any comments from the public on any agenda item on today's agenda. There were none.

#### **Program Status Report**

Mr. Conrad asked Mr. Etwert to provide a status report for the project.

Mr. Etwert indicated that work continues on the acquisition of easements needed to complete the projects that have been awarded. He reported that Husch Blackwell continues to work with the attorneys for Union Pacific, regarding the 3 parcels needed on the BP #3 construction project. It does appear that we are getting close to the obtainment according to their attorney. These are the last easements needed for the 100-Year projects. As previously mention, the delay in obtaining these easements and others on the BP #7B project will have an effect on completion times and costs of these projects

Approximately 59% of the \$46.7 million of construction, involved in the eight current construction bid packages (not including BP 7B), has been completed thru February. With 1.4 million dollars' worth of construction completed in February, the total amount of construction completed is now \$27.8 million.

He indicated that there were two change orders on this month's agenda, involving Relief Well Construction Obstruction on Bid Package #3 and Relief Well Design Improvements on Bid Package #6 with Amec Foster Wheeler explaining them later in the meeting.

He noted that the Council has received Standard & Poor's three year review of our Series 2010A-C revenue bonds. The bonds continue to have a AA long-term rating with a stable outlook. A copy of the report was provided to each Board member.

Next he indicated that he and AMEC Foster Wheeler continue to meet with the Corps of Engineers regarding the process of the Council moving ahead with 500-year level of protection projects. Topics discussed include the most cost effective and highest priority projects, roles and responsibilities, coordination of design efforts, possible utilization of Corps designs, Limited Reevaluation Reports (LRRs), schedules & coordination, reviews, the Work In Kind (WIK) process, the Design process, etc. The 500-year authorized level of flood protection is the Corps' standard, and the Corps has the final say on what is and isn't 500-year protection.

The Corps has provided a ten page Guidance Scope of Work for In-Kind Contribution Credit Provisions to Amec Foster Wheeler and the FPD, which highlights all the procedures that the non federal sponsor must be follow, in order, to obtain credit.

All of these discussions will assist Amec Foster Wheeler in preparing a comprehensive work order, outlining the work to be done, that hopefully, will be brought before the Board in April for consideration of approval.

Once Amec Foster Wheeler has developed a schedule for identifying the most cost effective and highest priority projects, Columbia Capital, the Council's financial advisor, will develop a bond transaction schedule involving bond counsel, underwriters, rating agencies, etc.

Mr. Etwert noted, that while at the Corps the previous week, Colonel Mitchell asked to see him and indicated that he would like the Board to reconsider going forward with the Upper Wood River Shallow Cutoff Wall project, with bidders allowed to bid with a PLA, without a PLA, or both and the selection being the Lowest Price Technically Acceptable bid, which he feels would include a PLA. However, as previously, there is no guarantee of a PLA being utilized. He wasn't able to make today's meeting, but plans on attending the April meeting with his request.

Senator Durbin met last week with the Secretary of the Army and the Army Chief of Staff regarding the Corps' rejection of Project Labor Agreements (PLAs). It was indicated that they are reviewing the decision made by the District's Contracting Officer. A news release regarding the meeting was provided each Board member.

Mr. Etwert indicated that there would be an executive session regarding pending litigation at the end of the meeting.

The Board was provided copies of the Amec Foster Wheeler's Monthly Progress Report for March.

#### **Budget Update and Approval of Disbursements**

Mr. Conrad asked Mr. Etwert to provide a report.

Mr. Etwert noted that financial statement for February 2015 prepared by our fiscal agent, CliftonLarsonAllen was included in the materials sent for the meeting. The report included an accounting of revenues and expenditures for the month ending February 28, 2015, as compared to the fiscal year budget.

Accrued expenditures for the current fiscal year beginning on October 1, 2014 are \$18,669,205 while revenues amounted to \$4,752,509 resulting in a deficit of \$13,916,696. A total of approximately \$22,085,668 is held by the counties in their respective FPD sales tax funds and is available for the Council's use on the project.

Monthly sales tax receipts for December 2014 (the latest month reported by the Illinois Department of Revenue) were up by 4.61% from the previous year. Receipts were up 2.93% from last year and the total for 2014 was \$11,349,426, which is \$55,042 more than the previous highest year of 2012.

The report included bank transactions for February 2015. Total disbursements for the month were \$3,173,879.98. The largest payments were to Lane Construction for BP #6, Keller Construction for BP #3 and BP #5, Kiewit Infrastructure for BP #7B, Haier plumbing for BP #4, Korte & Luitjohan Contractors for BP #2B, Amec Foster Wheeler and Husch Blackwell.

Mr. Etwert recommended that the Board accept the budget report and disbursements for February 2015.

#### 2014 Audit Report

Mr. Etwert introduced Mr. Michael Brokering, representing Scheffel & Boyle, who prepared the 2014 Audit Report. Mr. Brokering introduced Mr. Steve Langendorf, a principal of Scheffel & Boyle, and then reviewed the audited financial statements that were distributed to the Board in the mailing and at the meeting. He explained the statements, tables and notes in detail.

He stated that the Council financial statements for the year ended September 2014 had been audited and were found to represent fairly in all material respect and therefore, the Council received a clean opinion. He pointed out that the financial statements are the Board's responsibility as management, and that Scheffel & Boyle's responsibility is to issue an opinion on the statements.

Two required communication letters from Scheffel to the Board accompanied the audit and were also discussed. The first letter discussed weaknesses in internal controls. This comment, which is not new, is that due to the small size of the Council's staff, there is some limitation in financial controls. There were no material weaknesses in the Council's internal controls. Mr. Brokering noted that this is pretty common in very small organizations, and noted that it was important for the Board to continue to review disbursements and financial statements monthly. He noted that CliftonLarsonAllen does provide a level of oversight. The second letter pointed out that there were no difficulties in performing the audit, but that several adjustments were made to the financial statements. There are no audit findings to report.

Mr. Long asked if Scheffel Boyle performed any third party vendor analysis to which the response was no, however they do review all large dollar invoices and no issues were found. It was indicated that two signatures are required on all checks that are written.

Mr. Bergkoetter asked whether the investments made by the Council are reflected in the capital assets of the levee districts. He noted that we need to let them know how much we expend so that they will know how their capital assets are affected. Mr. Etwert indicated that he would advise the levee districts of the additional capital assets as projects are being built, completed and placed into service.

#### **Design and Construction Update**

Mr. Conrad called on Jay Martin, AMEC's program manager, to provide a report. Mr. Martin used a PowerPoint® presentation to illustrate his remarks. His presentation, including a few site photos, focused on the status of each bid package as follows:

#### **Construction Status**

#### **BP #2A – Fish Lake Pump Station**

- Essentially complete.
- Contractor/AMEC developing record documents

#### **BP #2B – WR/MESD/PDP Pump Stations**

• Site 5, 10, 12, 15, 16 – Pump station is complete. Pre-final inspections accomplished and punch lists developed.

#### **BP #2C – Site 12 Pump Station Force Mains**

- Work on this site will not begin until October 15, 2015 to comply with 33 U.S.C. 408 (Section 408 alteration permit)
- NTP will be issued later this year

#### **BP** #03 – WR Seepage Improvements

- Critical Delay: The railroad land acquisition delay is impacting full mobilization to Blanket Drain 6, Seepage Berms 1-4 and Random Fill Areas 1 & 2.
- Design revisions to Blanket Drain 4 and Weirs 2, 3, & 4 pending. Construction cost impacts will be submitted next month.

- Piezometer installation continues 36 of 51 PZs complete. Concrete seals and bollards also being installed.
- Blanket Drain 3, 5, & 7 and Weir 1 in progress.

#### **BP # 04 – MESD Seepage Improvements (Conoco Phillips)**

- Relief well drilling complete.
- Site 09 Intake Structure complete. Electrical rough in to begin this month.
- RW collector system mainline complete. Laterals to relief wells remain.
- Relief Well conversions and Relief Well manhole work to begin this month.
- Clay Cap work is delayed until Spring/Summer 2015.

#### BP # 05 – MESD Seepage Improvements (MESD excluding Conoco Phillips)

- Platforms were built to allow relief well drilling to resume. Forty-one of 72 RWs have been drilled.
- Relief well collector system on south flank of MESD by Site 10 and Site 16 pump stations complete.
- Piezometer installation continues 6 of 18 PZs complete
- Clay Cap work is delayed until Spring/Summer 2015.

#### **BP # 06 – PDP/FL Seepage Improvements**

- Relief well drilling continues. Forty-four of 67 RWs have been drilled.
- Sluice Gate rehabilitation/replacement complete.
- Lining of the triple 84" culverts at Palmer Creek Pump Station continues. Two of 3 culverts have been lined and grouted.
- Production on seepage berms and clay caps is progressing as weather allows.

#### **BP #7A – Shallow Cut Off Wall**

• Levee backfill/clay cap delayed until weather conditions are suitable to obtain the proper compaction.

#### **BP # 7B – Deep Cut Off Wall**

- Re-advertised Sunday March 15, 2015
- Plans available march 20, 2015
- Pre-bid scheduled for April 1, 2015
- Bids due May 6, 2015

#### Change Orders BP #3 and BP #6

Mr. Conrad asked Mr. Etwert to explain this item.

Mr. Etwert indicated as he mentioned in the Progress Report earlier that there were two change orders on the agenda, which AMEC would be explaining. They involve Relief Well Construction Obstruction on BP #3 and Relief Well Design Improvements on BP #6. He stated per the Board's Construction Change Order Policy, any change order which causes a line item to increase by more than ten percent must be approved by the Board. Board approval is also required on all change orders if the total of all change orders on a project exceed ten percent of a project's original cost, which currently applies Bid Packages 3 & 6.

Mr. Martin provided the following explanations:

Bid Package #3 – Change Order 11 - Relief Well Construction Obstructions \$500,000.

Relief well drilling depths varies throughout the bid package projects and may be over 100 feet deep. Once a relief well hole is initiated, the drillers continue the installation until the well is completed, otherwise the well hole will collapse and installation would start over. During relief well drilling, we expect that the drillers will encounter layers that contain large diameter (greater than 5 ½ inches) cobbles as has been the case on other reaches of the levee. These layers range in thickness from a few feet to over 10 feet.

The Contract requires that the contractors provide and use drills and equipment capable of drilling through and removing cobbles up to 5 ½ inches in diameter. This requirement is met with all the relief well drilling contractors. A construction obstruction is determined to exist if the contractor is required to drill through a layer with cobbles greater than 5 ½ inch in diameter.

Amec Foster Wheeler will have a full time construction inspector on site observing the entire well installation and drilling operations. Amec Foster Wheeler determines when further efforts to advance the drill hole are impracticable. Per the Contract, such demonstration includes continuing drilling operations when no gain in depth is being made for a minimum of 30 minutes. When this is the case, the Contractor must change his drilling operations, and this would be considered to be above the contract requirements (change order).

When these construction obstructions are encountered Amec Foster Wheeler engineers evaluate the situation and determine whether to continue the drilling efforts and to what depth. Instead of abandoning the well, which is not cost effective, the Amec Foster Wheeler engineers review the new aquifer penetration and calculated screen entrance velocities, review other adjacent well depths and review the design requirements. When feasible, the wells will be terminated shorter than the design depth. The reduced depth is a cost savings to the contract but, there is a cost associated with drilling the construction obstruction layer. There are 84 relief wells planned in bid package 3.

Amec Foster Wheeler has negotiated a time and material cost rate with the contractor for drilling though construction obstruction layers. Please note that AMEC anticipates relief wells may encounter conditions outside the scope of the current contract and AMEC recommends approving \$500,000. This is similar to the action taken for relief well construction obstruction on BP 5 and BP 6 in January.

#### Bid Package #6 – Change Order 17 - 60 Slot Relief Well Designs \$63,230.97

Re-design relief well to use a 40-slot screen and RF40 filter pack instead of 60-slot screen and RF60. During the pump tests in Bid Package 05, two of the three 60-slot size relief wells failed due to sanding. This indicates the possibility for undiscovered fine layer sand that was not retained by the filter pack. In coordination with USACE, the 60-slot size will change to 40-slot size (with appropriate filter packs). Install RW 18X, 22C, 22D, 51A, and 112X, remove failed 60-slot original 18X, purchase of 40-slot screen, riser sections and filter pack.

There was a brief discussion concerning the slot sizes and filter packs.

Mr. Etwert pointed out that on BP 03 that there are 84 relief wells and on a worst case scenario the cost could be two to three times the amount requested at this time, hopefully that won't be the case.

Mr. Etwert requested that the Chief Supervisor be authorized to approve BP #3 Change Order 11 for Relief Well Construction Obstructions for \$500,000.00 with Keller Construction and BP #6

Change Order 17 for 60 Slot Relief Well Designs for \$63,230.97 with Lane Construction. Total cost of these all change orders not to exceed \$563,230.97.

Mr. Conrad asked for a motion to accept the recommendation on the change orders. A motion was made by Mr. Long with a second by Mr. Brinkman to authorize the Chief Supervisor to approve BP #3 Change Order 11 for Relief Well Construction Obstructions for \$500,000.00 with Keller Construction and BP #6 Change Order 17 for 60 Slot Relief Well Designs for \$63,230.97 with Lane Construction. Total cost of these change orders not to exceed \$563,230.97.

#### Office Lease

Mr. Conrad asked Mr. Etwert to explain this item.

Mr. Etwert explained that the Council has had a lease to occupy office space with the Metro-East Park and Recreation District at 104 United Drive in Collinsville since July 2009. The current two year extension has recently expired.

There is no cost to the Council, other than internet service and maintaining liability insurance on the space. The arrangement has worked out very well for the Council and contributes to the very low administrative costs for the project.

The MEPRD has agreed to extend the lease for three years to December 31, 2017, under the same terms as conditions. A copy of the lease was provided in the agenda package.

Mr. Etwert requested that the Chief Supervisor be authorized to approve the three year extension of the existing lease for office space, from the Metro-East Park and Recreation District, to December 2017.

# Renewal of Federal Government Relations and Advocacy Services with Smith Dawson & Andrews

Mr. Conrad asked Mr. Etwert to explain this item.

Mr. Etwert explained that Smith Dawson and Andrews (SDA) has provided federal government relations and advocacy services to the Council for the last two years.

Their initial efforts were focused on the reauthorization of the Water Resources Development Act, assisting the FPD with the local Illinois Congressional delegation, Senators Durbin & Kirk, Representatives Davis, Enyart/Bost & Shimkus and the Committee staff of the Authorizing Committees, House Transportation & Infrastructure and the Senate Environment & Public Works Committees, the House and Senate Energy and Water Development Appropriations subcommittees, and several national water coalitions.

SDA continues, on the FPD's behalf, to interact with the Congressional delegation Washington based staff on the labor issues with USACE, the execution of provisions related to FPD projects addressing cost share, project crediting, treating the individual levee system projects as a single system entity, the public private partnership pilot program, and monitoring program guidance and implementation of the WRRDA bill.

The Corps' continued resistance to "requiring" PLAs remains a significant problem, despite the delegations efforts to engage. However, the Congressional delegation remains supportive of the FPD's position on PLAs which has been reinforced by the FPD's Resolution passed on February 18, 2015.

SDA will continue to work with the FPD to execute a legislative and administrative agenda and continue to maintain good relationships with the delegations Washington staff as well as Committee staff. It will be important to maintain contact and to keep the delegation members and staff appraised of the FPD's progress in addressing the levee upgrades. There are a number of new staff members working on this issue that will be engaged as we go forward.

A summary of services to be provided was included in the agenda package.

Mr. Andrews has been quite helpful keeping us informed and advocating our position to members of our congressional staff on Projects Labor Agreements (PLAs), the WRRDA 2014 provision allowing consolidation of levee projects, and our interest in the Corps' Public-Private Partnership Pilot Program also allowed by WWRRDA 2014.

We will continue to have legislative, regulatory, and financial interests at the federal level dealing with the Corps of Engineers and the Federal Emergency Management Agency, as well as new issues as they arise, such as, the recent executive order establishing a new Federal Flood Risk Management Standard.

Mr. Etwert indicated it would be advantageous to continue the agreement with Smith Dawson & Andrews to provide government relations and advocacy services to the Council at a cost of \$5,000/month thru April 2016. The agreement can be terminated with thirty days' notice. This rate is under the market rate for this type of representation.

A motion was made by Mr. Parks with a second by Mr. Maher to authorize the Chief Supervisor to execute a contract with Smith Dawson & Andrews to provide federal government relations and advocacy services to the Council from May 1, 2015 thru April 30, 2016 at a cost of \$5,000 a month.

#### **Corps of Engineers Update**

Mr. Conrad asked Ms. Kelsey to provide the report from the Corps.

Ms. Kelsey then used a PowerPoint<sup>®</sup> presentation to provide the Project Status of the Metro East Projects. She indicated that Col. Mitchell was in Washington and couldn't attend todays' meeting but hopes to attend next month. She then went over the presentation was being given to our congressional delegation.

First she discussed Wood River and the finishing up of reconstruction and trying to make headway on the Design Deficiency Project. Wood River has an FY 15 Allocation of \$50,000 and an FY 16 Budget of \$50,000 with an FY 16 Total Capability of \$50,000. Capability could increase based on the progress of cost share funds or work in-kind credits. For FY 15 the Corps is continuing the design of underseepage corrections, performing Section 408 construction observations, has executed the MOU, is preparing an Integral Determination Report (IDR) which will identify what work would be eligible for credit and closing out the reconstruction project. The Corps is in position to award the Upper Wood River Shallow Cutoff Wall which would close out the work in Upper Wood River. The Corps is offering to solicit this project with a voluntary Project Labor Agreement (PLA) for the lowest-price technically acceptable bid and not a mandated PLA.

Next, she discussed the completion of the risk assessment of Melvin Price Lock and Dam and the moving forward with the review of alternatives that will be utilized for the final solution. The project has an FY 15 Allocation of \$3,600,000 with an FY 15 Additional Capacity of \$900,000. The FY 16 Budget is \$2,000,000 with a Total Capability of \$2,000,000. The Corps continues to move forward completing the supplemental report and identifying what the new solution will be for Melvin Price project and monitoring and upgrading the Interim Risk Reduction Measures (IRRM) until a permanent solution can be put in place.

There was a brief discussion the regarding the reimburse of funds to the City of Alton for a recreational aspect that was part of the Mel Price project that the City moved forward and built with the expectation that the City would be reimbursed.

East St. Louis was discussed next with the Corps moving forward with the Design Deficiency Project and finalizing the rehab project. East St. Louis has an FY 15 Allocation of \$50,000 and an FY 16 Budget of \$50,000 with an FY 16 Total Capability of \$50,000. For FY 15 the Corps is continuing the design of underseepage corrections, performing Section 408 construction observations, has executed the MOU, and is preparing an Integral Determination Report (IDR) which will identify what work would be eligible for credit. Funds in FY 16 will be used for project oversight.

Ms. Kelsey was asked how much the area had lost due to the lack of a PLA inclusion by the Corps, to which she responded approximately \$40,000,000.

Chain of Rocks which is at the authorized level of protection was discussed next. No funds have been requested for FY 15 or FY 16. FY 14 carryover funds will be used for to continue the project closeout. The Corps continues to coordinate with AMEC on how to incorporate Chain of Rocks in their East St. Louis certification process.

Lastly, the Prairie Du Pont Levee & Sanitary District and the Fish Lake Drainage & Levee District were discussed. No funds are Allocated or Budgeted for FY 15 or FY 16, but a Total Capability of \$200,000. has been indicated for FY 16 to prepare the Integral Determination Report for Work In-Kind Credit eligibility and prepare Project Partnership Agreement. The Corps is looking at how the 100-Year projects will impact the authorized level plan.

Husch Blackwell continues to work with the attorneys for Union Pacific, regarding the 3 parcels needed on the BP #3 construction project. Final changes are being made to the forty page Stormwater Drainage Improvements Construction & Maintenance Agreement required by Union Pacific. As previously mention, the delay in obtaining these easements and others on the BP #7B project will have an effect on completion times and possible costs of these projects

Approximately 65% of the \$46.8 million of construction, involved in the eight current construction bid packages (not including BP 7B), has been completed thru March. With 2.7 million dollars' worth of construction completed in March, the total amount of construction completed is now \$30.2 million.

We have one change order on this month's agenda, involving Handrail & Toe Wall Additions to Weirs 2, 3, and 4 on Bid Package #3. Amec Foster Wheeler will be explaining these at the meeting.

AMEC Foster Wheeler and I continue to meet bi-weekly with the Corps of Engineers regarding the process of the Council moving ahead with 500-year level of protection projects. On Wednesday's agenda there will be a work order for Amec Foster Wheeler to start the process of analyzing and planning the USACE Authorized Level of protection.

On April 1<sup>st</sup>, there was a pre-bid meeting with site visit for the re-bid of Bid Package 7B – Wood River Lower Cutoff Wall Project. Attendance was good with over a dozen firms participating.

I have attached Col. Mitchell's letter of March 16<sup>th</sup> (previously e-mailed to each of you) requesting the Board to reconsider going forward with the Upper Wood River Shallow Cutoff Wall project, with bidders allowed to bid with a PLA, without a PLA, or both and the selection being the Lowest Price Technically Acceptable bid, which he feels will include a PLA. However, as previously, there is no PLA guarantee. He is schedule to attend Wednesday's meeting.

There will be an executive session on litigation and real estate at the end of the meeting.

I have included in your Board packet a copy of Amec Foster Wheeler's Monthly Progress Report for April.

Dear Mr. Etwert:

Thank you for meeting with me briefly on March 11, 2015 to discuss the progress of the Metro East projects. As I expressed during my initial meeting with the Southwestern Illinois Flood Prevention District Council (FPD) Board in July of 2014, my priority, and the priority of my Agency, is to reduce the flood risk by fully restoring the Metro East Levees so that they can consistently operate as they were originally authorized.

St. Louis District has listened to the Board's concerns regarding the incorporation of Project Labor Agreement (PLA) requirements into our construction contracts. The district has considered their request and has returned with a path forward, specifically with the incorporation of PLA provisions in Lowest Price Technically Acceptable solicitations. Currently, there are approximately \$6.7 million in ongoing construction in the three county areas, with 14 contractors (five from Illinois) actively working on these projects. Collectively, 76 building and trade related jobs have been employed with 56 of those being filled by union employees. This does not take into consideration suppliers, delivery services or other support services. In summary, 75% of the jobs are being filled by union employees in the Metro East area without mandated utilization of a PLA.

The district is now in a position of opportunity to renew our joint partnership and take REAL, tangible actions toward reducing flood risk for these communities. We have completed the design of the Shallow Cutoff Wall for Upper Wood River and we are prepared to move forward to construction. This is the final piece of work remaining to be accomplished within the Upper Wood River system that was authorized by the Wood River Limited Reevaluation Report. We also currently have sufficient federal funds in place to execute this work now. However, your sponsor's cost share portion has not been provided. We are unable to execute work on the project until the FPD provides cost share funds.

I renew my repeated requests to you to provide the necessary sponsor cost share funds to construct this feature of work. By doing so, your action will result in several

accomplishments: (1) Most importantly, this effort will reduce flood risk in the Upper Wood River levee system (2) You will see the placement of nearly \$3 of construction for every \$1 you invest in this effort (3) You will see firsthand the efficacy of the PLA incorporation plan that we have established for the Metro East projects and (4) Your investment will demonstrate your commitment to sponsorship in the federally authorized project. Tangible evidence of that continued commitment is critical to the project's ability to successfully compete for future federal appropriation in an era of ever decreasing budgets and ever increasing competition for every appropriated dollar.

I regret that I am unable to attend your monthly meeting on March 18. I will be in Washington DC during that time visiting members of Congress to discuss our capabilities in light of the President's budget proposal for Fiscal Year 2016. As I visit with members of the Illinois delegation, I fully intend to communicate the capability that we have for this project. The ultimate goal is to reduce flood risk by fully restoring the levees. We can only achieve this goal through collaborative effort and commitment.

I am providing a copy of this letter to the Wood River Levee and Drainage District.

#### 1. OVERVIEW

#### 1.1 Project Description

Levees along the east side of the Mississippi River within four levee districts have been found to be out of compliance with FEMA Requirement 44CFR 65.10 and therefore have been de-certified. The four districts are: Wood River Drainage and Levee District, Metro-East Sanitary District, Prairie du Pont Drainage and Levee District, and Fish Lake Drainage and Levee District. The counties involved have formed an overarching entity called the Southwestern Illinois Flood Prevention District Council (SIFPDC). Amec Foster Wheeler has been selected by the SIFPDC to design and manage the construction of levee system improvements necessary to demonstrate compliance with FEMA Requirement 44CFR 65.10.

**Bid Package 2A** is composed of the construction of one (1) pump station within the Fish Lake Levee District System.

**Bid Package 2B** is composed of the construction of five (5) pump stations within the Wood River, MESD, and Prairie du Pont Levee Districts.

**Bid Package 2C** is composed of the installation of two force mains and associated structures from Site 12 pump station to levee discharge.

**Bid Package 3** is composed of the construction of seepage control improvements within the Wood River Drainage and Levee District Levee System.

**Bid Package 4** is composed of the construction of seepage control improvements within the Metro East Sanitary District Levee System, from Station 1209+00 to 1242+00. This package also includes the construction of one (1) pump station.

**Bid Package 5** is composed of the construction of seepage control improvements within the Metro East Sanitary District Levee System.

**Bid Package 6** is composed of the construction of seepage control improvements within the Prairie du Pont Drainage and Levee District and Fish Lake Drainage and Levee Systems.

### **Current Budget Highlights**

Attached is the financial statement for March 2015 prepared by our fiscal agent, CliftonLarsonAllen. The report includes an accounting of revenues and expenditures for the month ending March 31, 2015, as compared to our fiscal year budget.

Accrued expenditures for the current fiscal year beginning on October 1, 2014 are \$20,860,791 while revenues amounted to \$5,918,296 resulting in a deficit of \$14,942,495. A total of approximately \$23,015,535 is held by the counties in their respective FPD sales tax funds and is available for the Council's use on the project.

Monthly sales tax receipts for January 2015 (the latest month reported by the Illinois Department of Revenue) were up by 6.64% from the previous year. Receipts for January were \$27,230 higher than the previous highest January of 2013

### Monthly Disbursements

Attached is the list of bank transactions for March 2015. Total disbursements for the month were \$1,643,461.74. The largest payments were to Keller Construction for BP #3 and BP #5, Lane Construction for BP #6, Haier Plumbing for BP #4, Korte & Luitjohan Contractors for BP #2B, Kamadulski Excavating & Grading Co., Amec Foster Wheeler and Husch Blackwell.

We have not audited or reviewed the accompanying financial statements and, accordingly, do not express an opinion or provide any assurance about whether the financial statements are in accordance with accounting principles generally accepted in the United States of America.

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for designing, implementing, and maintaining internal control relevant to the preparation and fair presentation of the financial statements.

Our responsibility is to conduct the compilation in accordance with Statement on Standards for Accounting and Review Services issued by the American Institute of Certified Public Accountants. The objective of a compilation is to assist management in presenting financial information in the form of financial statements without undertaking to obtain or provide assurance that there are no material modifications that should be made to the financial statements. During our compilation we did become aware of departures from accounting principles generally accepted in the United States of America that are described in the following paragraph.

Management has omitted the management discussion and analysis. Such missing information, although not a part of the basic financial statements, is required by the Governmental Accounting Standards Board, who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context.

Management has not presented government-wide financial statements to display the financial position and changes in financial position of its governmental activity. Accounting principles generally accepted in the United States of America require the presentation of government-wide financial statements. The change in fund balance for the Council's governmental activity is not reasonably determinable.

Management has not presented a balance sheet for the general fund. Accounting principles generally accepted in the United States of America require the presentation of a balance sheet for each fund contained in the financial statements. The amounts that would be reported in a balance sheet of the general fund for the Council are not reasonably determinable.

Management has not presented a change in fund balance on the Statement of Revenues and Expenditures – Budget and Actual. Accounting principles generally accepted in the United States of America require the Statement of Revenues, Expenditures and Changes in Fund Balance include a presentation of changes in fund balance. The amounts that would be reported in government-wide financial statements for the Council's governmental activity is not reasonably determinable.

Management has also elected to omit substantially all of the disclosures required by generally accepted accounting principles. If the omitted disclosures were included with the financial statements, they might influence the user's conclusions about the Council's results of operations. Accordingly, these financial statements are not designed for those who are not informed about such matters.

The accompanying original and final budget amounts presented on the General Fund Statement of Revenues and Expenditures – Budget and Actual presented for the year ending September 30, 2015 and 2014, have not been compiled or examined by us, and, accordingly, we do not express an opinion or any other form of assurance on them.

We are not independent with respect to Southwestern Illinois Flood Prevention District Council.

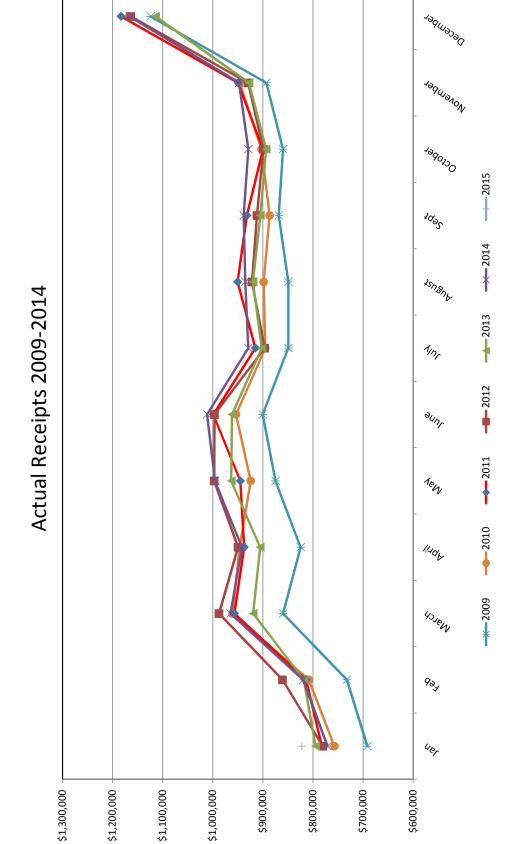

Last June the Board approved the rerouting of an Ameren Illinois primary service line involving the permanent relocation of a pole to avoid proposed relief wells construction during the Wood River Levee Deep Cutoff Wall Project.

The thought at the time was that the pole would be relocated to a new location and a new easement would be granted by the Olin Corporation. Unfortunately, Ameren Illinois has not been able to work out an agreement with Olin Corporation for the relocated pole and the pole is will have to go back to its originally location.

The cost for moving the pole back to its original location is \$35,793.00.

<u>Recommendation:</u> Authorize the Chief Supervisor to enter into an agreement with Ameren Illinois to relocate a primary service line back to its original corner location after the construction of proposed relief wells in the Wood River Levee Deep Cutoff Wall Project at a cost not to exceed \$35,793,00.

Subject: Change Order BP #3

Date: April 13, 2015

Per the Board's Construction Change Order Policy, any change order which causes a line item to increase by more than ten percent must be approved by the Board. Board approval is also required on all change orders if the total of all change orders on a project exceed ten percent of a project's original cost, which currently applies Bid Packages 3 & 6.

We have one change order on Bid Package 3, which Amec Foster Wheeler will be explaining at the meeting.

## Bid Package 03 – Change Order 13 - Handrail & Toe Wall Additions to Weirs $2, \, 3$ and $4 \, \$60,\!362.00$

Three of the storm water control weirs planned for Bid Package 03 have been modified to include a toe wall for additional structural support due to the field conditions and soil types the weirs are being installed in. The initial assumptions made during the structural engineering calculations for the slopes on which the weirs are being installed in were found to be different than the actual field conditions; the field conditions exhibit a steeper slope, and therefore a greater chance for an overturning failure scenario. The toe walls were added to mitigate this potential failure.

Handrails were added to the weirs as a result of OSHA regulations; handrails are required for a structure where the vertical distance is to the area below is greater than 36". The weirs are being considered structures; therefore handrails were added for maintenance personnel safety during inspections and flood events.

Recommendation: Authorize the Chief Supervisor to approve BP #3 - Change Order 13 – Handrail & Toe Wall Additions to Weirs 2, 3, and 4 with Keller Construction at a cost not to exceed \$60,362.00.

USACE Authorized Level of Protection Planning and Analysis

As I indicated at last month's meeting, Amec Foster Wheeler would be presenting a comprehensive Work Order involving the Analysis and Planning of the USACE Authorized Level of Protection for our region, to determine the most cost effective and highest priority projects in the Counties of Madison, Monroe, and St. Clair, Illinois.

Amec Foster Wheeler will review specific Authorized Level improvements identified by the Corps of Engineers, all supplemental reports, and additional pertinent documents to develop a schedule for the design and construction of Authorized Level improvements.

Amec Foster Wheeler will also provide program management in support of the design and construction of improvements associated with the USACE Authorized Level Project.

Once the Council has reviewed the deliverables of this work order, an additional scope of services work order will be prepared reflecting the Council's preferred sequence of design and construction.

It must be noted that the schedule and cost information contained in this work order are dependent on the USACE providing information in a timely manner.

At the meeting on Wednesday, Amec Foster Wheeler will provide an overall schedule reflecting all the benchmarks that will have to be dealt with during the process of achieving the Authorized Level of Protection.

A detailed scope of work and cost estimate for the USACE Authorized Level of Protection Planning and Analysis is attached to this memo.

**Recommendation:** Authorize the Chief Supervisor to execute Work Order 12 with Amec Foster Wheeler Environment & Infrastructure Inc. for the USACE Authorized Level of Protection Planning and Analysis, as shown in the attachment, in the amount of \$270,000.

**WORK ORDER NO: MSA01-WO12** 

#### A. OVERVIEW

Amec Foster Wheeler's services will include review of the specific Authorized Level improvements identified by the U.S. Army Corps of Engineers (USACE) in the Wood River Levee System Limited Reevaluation Report, Design Deficiency Corrections, Wood River Drainage and Levee District, Madison County, IL, approved August 31, 2011; the Limited Reevaluation Report and Environmental Assessment, Design Deficiency Corrections, East St. Louis, Illinois Flood Protection Project, approved August 2010; and the approved Prairie du Pont / Fish Lake reevaluation report (to be provided by USACE) (the "Reports"). Amec Foster Wheeler will also review supplemental reports and additional pertinent documents (if any are available) prepared after the reevaluation reports, if provided by USACE. Amec Foster Wheeler's review of the reports is for the purpose of proposing a schedule to the Southwestern Illinois Flood Protection District Council (SIFPDC) for the design and construction of Authorized Level improvements identified by USACE. Amec Foster Wheeler's services do not include an analysis of the existing condition of the levees or an analysis of whether the improvements recommended in the Reports provide the level of protection indicated and/or desired by USACE. Amec Foster Wheeler is relying upon the Reports for such recommendations and identification.

This Work Order (MSA01-WO12) will include Task B as described below, and program management during performance of Task B. The remaining services necessary to complete the design and construction of the Authorized Level improvements will include: field and laboratory services (e.g., drilling pilot holes, drilling soil borings for pump station design and cutoff wall design, laboratory testing of soil samples, surveying, utility locating); final design of relief wells (depth, filter type, screen placement, etc.); design of pump stations and conveyance systems; preparation of construction drawings and technical specifications; contract administration; and, construction management. A detailed scope for these additional services will be prepared after the submittal of Task B deliverables to SIFPDC and receive receiving its input on the preferred sequence of design and construction. Please note that the schedule and cost information contained in this work order are dependent on USACE providing information in a timely manner.

#### B. REVIEW THE STATUS OF USACE AUTHORIZED LEVEL DESIGN

#### **Task Objective**

The goal of the proposed services is to evaluate the current status of USACE efforts to improve levees to the Authorized Level of protection, and develop an approach which the SIFPDC can undertake to perform design and construction of the improvements for the Authorized Level. This task will address Upper Wood River (UWR) except for the Mel Price area (which USACE has designs under way for), Lower Wood River (LWR), Metro East Sanitary District (MESD) and Prairie du Pont - Fish Lake (PDP/FL) levees. The Chain of Rocks levee segment is not



included, as it is completely managed by USACE. The Melvin Price Underseepage Design Deficiency Project, which has not yet been completed by USACE as of the date of this task order, is not included. The Wood River East Fork and Wood River West Fork Levees are not included because it is understood improvements are not needed on these levees.

#### **Background Information**

We understand the USACE design efforts are generally at a preliminary design stage as of the date of this task order. We expect USACE has identified design reaches as deficient based on calculations of exit gradients and the associated factors of safety (FOS) at the landside levee toe and has selected a remedial solution for each reach based on these calculations. It is likely that the exit gradients were calculated using leaky blanket theory, with a few areas analyzed in more depth using finite element models. USACE provided a table that lists the design reaches and calculated FOS for LWR and MESD levees. We expect additional available information about the current design status will come from interviews and meetings with USACE personnel and the existing USACE reevaluation reports for each levee.

#### **Review of Reports**

Amec Foster Wheeler will review the existing USACE reevaluation reports for each of the referenced levees, interview USACE, and review the FOS tables. If necessary, Amec Foster Wheeler will develop an FOS table for the PDPFL levee using the USACE reevaluation report and any supplemental information received.

Amec Foster Wheeler will rely on the USACE underseepage preliminary designs (in the Reports) to specify which reaches of levee require improvements to meet the Authorized Level design. Improvements are understood to be relief wells, seepage berms, cutoff walls, and appurtenances such as pump stations and conveyance systems. For each USACE design reach, Amec Foster Wheeler will consider items including: permitting and land acquisition requirements; complexity of final design; current USACE status; construction duration; and, estimated construction cost. Amec Foster Wheeler will develop a recommended list of individual projects, made up of specific design reaches, so that the SIFPDC can forecast spending by project as well as by design reach. Amec Foster Wheeler will evaluate the land acquisition needs associated with each recommended construction bid package; the SIFPDC may then use these evaluations for the purpose of scoping land acquisition services. Amec Foster Wheeler will prepare preliminary level construction cost estimates for each design reach, and use said cost estimates to aid in the approach presented to the SIFPDC. The cost estimates will summarize estimated costs by levee system and by county.

#### Report

Amec Foster Wheeler will prepare a concise Authorized Level Design Approach report for areas/reaches where USACE has completed and formalized its preliminary design solutions. The Authorized Level Design Approach report will include a tiered approach to moving forward with Authorized Level design and construction activities. The report will include:

- Narrative describing the information obtained
- Map plates showing USACE solutions and FOS by design reach



- Tables showing estimated Design Cost, by USACE and by Amec Foster Wheeler, estimated USACE Review Costs, estimated Construction Costs, and estimated USACE Oversight Costs.
- Schedule of project activities, including USACE processes (Integral Determination Reports/LRRs/Project Partnership Agreements), Field Investigations, Design, and Construction.

#### C. PROGRAM MANAGEMENT PLAN DEVELOPMENT AND MAINTENANCE

Services to be provided by Amec Foster Wheeler under this Work Order include Program Management Services in support of the design and construction of improvements associated with the USACE Authorized Level Project.
